Our instructors place great emphasis on child development philosophies and evidence based practices as well as individual learning styles to achieve the best results and success for each student. We provide structure, discipline and fun simultaneously. We offer intro through advanced level course. Our goal is to provide youth and families a place they can call home.

Bling Tour works diligently to create connections and positive relationships between our students, families and the Surprise community.

General Studio Policies & Procedures For Creating Success

Attendance Policy - Classes

Participating in extracurricular activities requires dedication and commitment and absences hinder growth and development. We encourage all students to attend every class!

Before/After Class

Students are not to arrive any earlier than 10 minutes prior to class and must be supervised by an adult until class begins. When one class ends, another begins promptly; instructors are not responsible for watching students once class is dismissed. Please instruct your child to wait inside Bling Tour's facility for pick-up and to inform the front desk if their parent/guardian is late. Students are not permitted to wait outside for rides. Students are also not permitted to walk to CVS next door without a parent or guardian. In the event a student does not follow this procedure, parents will be notified immediately. Please know this is for the safety of our students.

Cancellation of Services

City of Surprise Classes: Bling Tour's City of Surprise classes run every 4-8 weeks. There is no need to cancel your registration if your child chooses not to participate in the next session. Simply do not register for the next session. In the event you do register, fees are due by the start of class and no refunds will be provided. If paying through the City of Surprise Recreation Portal, please contact the City directly for all inquiries and cancellations.

Regular Monthly Classes: Bling Tour's season runs for 12 consecutive months beginning in August and ending in July. Because we are only allotting a select number of spots in each class, we are holding this spot for your child and requires a **30 day cancellation notice.**

Class Cancellation/Changes

Bling Tour reserves the right to combine classes, change times, provide substitute teachers or replacement teachers, and cancel any class or rehearsals. These decisions will be made at the discretion of the Leadership Team.

Class Procedures

Please have your student arrive five minutes prior to class/rehearsal start time. Proper warm-ups are critical in the beginning of class and are vital to preventing injuries. Students should arrive dressed in the proper attire and shoes for each class. All students must wear their hair up at all times and also must wear tights, leotard and hair in a bun for all ballet classes. Additionally, dance/cheer/tumbling shoes are not to be worn on the street. Please be sure your child only wears their dance/cheer/tumbling shoes in our facility and during performances/competitions. It is imperative that street shoes are not worn on our spring and Marley floors. Additionally, there is no food or drinks allowed inside any of the classrooms.

Code of Conduct

Bling Tour is committed to building not only skill, but character and commitment. Positive character and commitment to their team/class creates trust and friendship as well as increases their social skill development preparing them for the real world. Bling Tour under no circumstance tolerates bullying, cyber bullying or negative use of social media within our Bling Tour community and beyond. In the event a student engages in this type of behavior, they will be communicated to (along with their parent) and provided a warning for this behavior. In the event the issue persists, Bling Tour will remove the student from our facility and all tuition and fees will be forfeited. No refunds will be provided.

How we treat others in our facility and community is very important to Bling Tour. We feel, however, that this key ingredient of positivity will move us toward developing an incredible company through trust and love for one another. This philosophy is unique to Bling Tour and what sets us apart. Please communicate with your child about this policy as this is not negotiable. It is our goal to help develop amazing human beings to become positive contributing members of our society. We have seen these skills can be developed as early as 2 years old and expect all students to exhibit and represent Bling Tour in a positive manner.

Communication

Bling Tour communicates with parents via our parent portal. Emails are sent from the parent portal to the email on file. Please keep your parent portal account up-to-date with current emails and phone numbers to ensure all communication is received. Additionally, we post weekly notifications (if not daily) on Bling Tour's Facebook Page. To receive these notification, please like our page at www.Facebook.com/BlingTour.

City of Surprise classes: are not eligible for the multiclass discount as the recreational classes are already offered at a discounted rate due to our partnership with the City of Surprise.

Family Discount: Bling Tour provides a 10% discount for the second child <u>under the same custodial parent/guardian</u>. This discount is not eligible for any of our City of Surprise classes. This discount may not be combined with any other discounts.

Performance Based Team Discounts: For families who have two children under the same custodial parent/guardian with both children enrolled in our one of our performance based programs, Bling Tour will be provide a 20% discount on performance based teams (Only) for the second child. This does not apply to any other classes and both students are ineligible for any other studio discounts. Additionally, no other discounts may be applied or combined for additional savings. The 20% discount will be applied to all monthly tuition fees for students participating on a performance based team/company. Both students must be on a performance based team/company to be eligible for this incredible discount. Discount is applied to the lesser amount.

Bling Tour also provides a 10% discount for the second child under the same custodial parent/guardian where one child is registered in a performance based program and the second child is registered in a monthly studio class. This discount is not eligible for any of our City of Surprise classes.

Programs eligible for this discount include: Performing Teams, Blingsical Theatre Company & Hip Hop Crew.

Competitive Team/Company Discounts: For families who have two children under the same custodial parent/guardian with both children enrolled in our competitive programs, Bling Tour will provide a 40% discount on Company/Cheer tuition (Only) for the second child. This does not apply to any other classes and both dancers/cheerleaders are not eligible for any other studio discounts. Additionally, no other discounts may be applied or combined for additional savings. The 40% discount will be applied to Competitive Monthly Tuition Fees (only) for dancers/cheerleaders participating on a team and does not include additional classes, intensives, or special events. Both students must be on a competitive team to receive this discount. Discount is applied to the lesser amount.

Bling Tour also provides a 10% discount for the second child under the same custodial parent/guardian where one child is registered in a competitive based program and the second child is registered in a monthly studio class. This discount is not eligible for any of our City of Surprise classes.

Programs eligible for this discount include: Dance Company and Performance Cheer.

Multi Team Discounts: In the event a child is selected to participate on two teams – performing or competitive a 20% discount will be applied to the lesser amount of the two teams.

MultiClass Discount for Team Members: Families may add additional classes beyond their team/company classes at the "Once a Week Monthly Discount Rate". Their Monthly Team Rate is considered their 1st Class at Full Price. Discounts will then be added based on the chart above.

Programs eligible for this discount include: Performing Team, Dance Company and Performance Cheer.

Only one discount may be applied per family and may not be combined with any other discounts.

Failure to Pay

Bling Tour is not in the business of causing financial hardship to any of our families. However, we are providing a high quality service and it is expected that all families will pay on time and keep their accounts up-to-date and in good standing. Dance Studios and Gyms require a great deal of time and financial commitment not only on the part of our families, but also our staff. In the event account balances are behind 30 days or more, you will first be asked to remove your student from all classes until you are able to get caught up on your account. In the event you are unable to meet your financial obligation incurred on your account, you will be completely removed from all classes and/or programs. Bling Tour will distribute notices for 3 consecutive months for failure to pay. Following the third notice, the collection process will be initiated.

Forms of Payment

Tuition: All accounts are required to maintain a credit card on file and automatic withdrawal is required for tuition. The only exception to this policy is for families opting to pay their tuition in full for the entire season (August-July). There are absolutely no refunds for tuition payments regardless if paying monthly or for the full season. Bling Tour provides a 4-day grace period for cards that have been declined/non-payment, etc. However, for each week that tuition goes unpaid, a \$10 late fee will be charged until paid.

Other Fees: All other fees may be paid with cash, check and/or credit card prior to the due date. If fees (optional participation) such as costumes, performances are not paid by the specified due date(s), Bling Tour will automatically withdraw the funds from your credit card within 5 business days following the due date and a \$10 late fee will be charged per item/transaction. A \$25 return check fee will be added onto all insufficient funded checks.

Observance

Regular Classes: Our highly experienced instructors have the discretion to allow window observation of all classes. In the event the curtains are closed, this is for the benefit of our students. Students are often distracted by their parents and our classes require full attention. Instructors have the discretion to keep their curtains open or closed. Please refrain from entering our classrooms at any time unless requested by our instructor. Our teachers are highly qualified, have been fully vetted, and are required to pass a background check every two years. As a Certified USA Gymnastics Gym, we have very strict requirements and protocols for all of our instructors. In the event a family member is visiting from out-of-state and would like to observe, please submit this special request to their instructor who has the final approval whether to grant this request.

Team Classes & Rehearsals: Observance of all classes and rehearsals is not permitted by team parents. Bling Tour will host closed rehearsals for our teams. This is for the benefit of our students so as to not cause distraction in their classes. This is also to benefit parents by limiting time spent in the hallways. Parents will be provided ample opportunity to observe their child during our performances, competitions, etc. In the event a family member is visiting from out-of-state and would like to observe, please submit this special request to their instructor who has the final approval whether to grant this request.

Parent Portal

Bling Tour utilizes a user friendly and secure software to accept online class registrations, track tuition, fees, payments, etc. Every parent will be set-up with an account and provided access to the parent portal online. This portal can be accessed on our website at www.BlingTour.com or by downloading the app in the "App Store" or "Google Play". Discounts will not be calculated online and must be set-up through the front office. Additionally, credit cards are not automatically charged upon registration. Please see the "Forms of Payment" section for our payment process.

Positive Parent Involvement

Parent involvement and positive interactions are critical to your student's success. Your ability to role model positive behavior is infectious and will make a significant difference regarding your student's experience at Bling Tour. Bling Tour does not tolerate negative behavior, comments or vibes in our facility from parents, students or staff. We work diligently to provide our students the most love and care through a positive child development philosophy which includes structure, discipline and fun. Your positive comments go a long way in encouraging your student as well as our instructors. In the event a parent is participating in gossip or spreading negativity, Bling Tour will communicate directly with the parent. If the behavior persists, the parent and student will be removed from their class/team/company and facility. This policy is put in place to support all of our amazing families, students, staff and instructors who are extremely positive and to remove all negative behavior from our space.

Private Lessons

Private lessons are at the discretion of the student's families and their instructor. Privates are not a part of Bling Tour and Bling Tour does not benefit from private lessons. All fees shall be paid directly to the instructor. However, in the event families are behind on tuition/other fees, private lessons will not be allowed until accounts are caught up-to-date. All private lessons hosted in our facility must first be approved by our Leadership Team and will be communicated

between the instructor and our Leadership Team. Finally, privates shall not be scheduled during a time where classes are occurring in the designated room as our first priority is to our Bling Tour classes and teams paying for the space. For questions, please email info@BlingTour.com.

Prorating

City of Surprise Classes: As the City of Surprise classes run every six weeks and they are offered at such an incredible rate, Bling Tour does not prorate these classes. Please wait till the next session to enroll.

Monthly Studio Classes (non-team): Bling Tour will prorate after the 15th of the month and accounts will be charged \$15 per class.

Teams: Bling Tour does not prorate for late start for our team students as we provide above and beyond the number of hours covered by monthly tuition throughout the entire season. In the event Bling Tour invites a student to join our team following the launch of our new season in August, we will work with each individual family to determine initial start-up fees for the weeks/months missed. Appropriate payment at the start of their first class will be required to ensure the student is caught up-to-date with all fees and payment schedule. It is our goal that all students will begin the season on the season launch date each year.

Refunds

Bling Tour also does not provide refunds once the class has begun or for services rendered. In the event a registrant cancels their participation in a class, the full monthly or session tuition is still do. If Bling Tour cancels a class, we will provide registrants a refund for the class cancelled (classes may be prorated if partial services have been rendered). Refunds are only provided in the event Bling Tour cancels a class or an event.

Tuition

Monthly Tuition: is <u>DUE ON THE 1ST OF THE MONTH. MONTHLY FEES REMAIN THE SAME REGARDLESS OF THE NUMBER OF DAYS, HOLIDAYS OR STUDENT ABSENCES. ADDITIONALLY, THERE ARE NO MAKE-UP CLASSES FOR MISSED CLASSES.</u> Due to the high volume of time and commitment dedicated to our classes, there are absolutely **NO REFUNDS** for tuition paid. A late fee of \$10 will be assessed for payments received after the 4th of each month – **NO EXCEPTIONS**. On the 5th, Bling Tour will automatically add the fee to your account and will continue applying a \$10 fee each week until tuition is paid. In the event tuition goes unpaid, Bling Tour reserves the right to remove a student from class and will be decided on a case-by-case basis at the discretion of Bling Tour's Leadership Team.

City of Surprise Tuition: can be paid via the City of Surprise recreational website or at www.BlingTour.com. All session tuition is due prior to the start of the class. In the event, the session is not paid by the first class, the student will be dropped from the class.

Annual Membership Fee: Bling Tour charges a \$30 annual membership fee every August and renews annually at the start of the new season. Annual Membership fee is not applicable for City of Surprise classes.

Attendance Policy

Participating on a team requires dedication and commitment. When a student is absent, it affects the entire team as well as their ability to successfully prepare for their upcoming events. In order to participate on one of our teams, your student must be present for the majority of their rehearsals/practices as well as performances/competitions. All team members must be present for every rehearsal and throughout the entire two weeks prior to a Competition. Breaking in this policy forfeits the student's participation in the competition. Additionally, absences without communication to the front office affects our entire team. It is critical if a student commits to being at a performance/competition, they attend so as not to disrupt or affect the rest of the team. Please email info@BlingTour.com and your Team Director to communicate a last minute change due to an unforeseen circumstance such as a family emergency, illness, etc. Please be cognizant and respectful of the rest of the team when absent. Every missed student affects the entire performance/competition. All performance/competition fees are non-refundable regardless of excused or non-excused absences.

Observance Policy

Bling Tour will host closed rehearsals/practices for all teams. This is for the benefit of our students so as to not cause distraction. This is also to benefit parents by limiting time spent in the hallways. Parents will be provided ample opportunity to observe their student during events.

Team Communication

Bling Tour communicates with Team Parents via Band. Parents are required to have the Band App and ensure they stay up-to-date as well as our Bling Tour app which can be accessed via the Apple App store or Google Play store. All events are via the Band App and all communication is sent via Band. This allows parents to receive ongoing communication, rehearsal schedules and calendar of events. Communication is vital to the success of our teams and ensuring everyone is where they need to be. Upon an invitation to join one of our teams via Band, please accept.

Tuition & Fees

Bling Tour makes every effort to layout all fees at the beginning of the season. Due to team formations following personal invites, Bling Tour reserves the right to make slight modifications to fee schedules up to October 1st each year. It is our goal to provide all information up front and keep parents fully informed. Following October 1st, Bling Tour will make all other fees and purchases optional.

STUDENT CANCELLATION FEE FOR TEAMS

Bling Tour's season runs for 12 consecutive months beginning in August and ending in July. By signing below, you and your student are accepting the commitment to remain with Bling Tour for the entire season as well as committing to the financial obligations outlined for this program. Bling Tour provides a great deal of extra time and commitment to our company/teams throughout the year and when a student quits, fees that have already been paid to instructors, facilities, etc. are lost causing a financial hardship to our company. Additionally, your student is securing a spot in routines that has a major implication when leaving our team. Due to this, in the event that your student is no longer able to participate on our team (leaves the team prior to the end of the season), you must provide a 30 day notice and your current month's tuition, last month's tuition (July) and any outstanding debt will be charged to your credit card

<u>on file.</u> Your child will lose their spot for the remainder of the season. It will remain at the discretion of Bling Tour's Leadership Team to allow any team member the opportunity to rejoin Bling Tour's team at a later date. <u>All fees on the account, must be paid prior to Bling Tour closing your account.</u>
